**ENTRIES FOR GUNDOG WORKING TESTS WILL ONLY BE ACCEPTED FROM GUNDOGS REGISTERED AT THE KENNEL CLUB IN THE GUNDOG GROUP (vide Reg. J1.a., J7a & B20)**

And if a registered dog has changed ownership the TRANSFER must be applied for before the closing of entries.

When entering more than one breed or variety, use if possible a separate form for each.

On no account will entries be accepted without fees, unless otherwise stated.
